

TERMS AND CONDITIONS

SG60 Icons of Home Collectables Giveaway Contest on Instagram

Acceptance of Terms and Conditions

- 1 The SG60 Icons of Home Collectables Giveaway Contest (the “Contest”) is organised by the Ministry of Culture, Community and Youth (“MCCY”). By participating in the Contest, you agree to these Terms and Conditions, including any changes to them from time to time (“T&Cs”). If you are below 18 years old, please obtain your parent or legal guardian’s consent for you to participate in the Contest.
- 2 The Contest is from 8 December 2025, 1000hrs, Singapore time to 14 December 2025, 2359hrs, Singapore time (the “Contest Period”). Only entries submitted during the Contest Period will be eligible for consideration.
- 3 MCCY may change the T&Cs and modify, cancel, or suspend the Contest in its sole discretion at any time without liability to anyone and without notice, save that notice of any cancellation or suspension of the Contest will be posted on MCCY’s Instagram page (@mccysg).

Eligibility and Contest Mechanics

- 4 The Contest is open to anyone residing in Singapore with a valid Instagram account.
- 5 To participate in the Contest, you must (i) follow MCCY’s Instagram page @mccysg, (ii) use the “add yours” template provided by MCCY for the Contest, and (iii) tag @mccysg when publishing your entry on to your Instagram Stories.
- 6 You are solely responsible and liable for Instagram stories or posts made under your name, username, or Instagram profile.

Selection and Notification of Winners

- 7 For the Contest, 60 winners will be selected at MCCY’s sole discretion from all eligible entries received during the Contest Period. Each winner will receive one (1) full set of SG60 Icons of Home Collectables (the “Prize”). Prizes are non-negotiable, non-transferable and non-exchangeable for cash or in kind.
- 8 All decisions made by MCCY relating to the Contest are final. MCCY is not obliged to provide reasons concerning the selection of the winners or entertain any appeals whatsoever.
- 9 Winners will be notified by MCCY via Direct Message (the “DM”) on Instagram within three (3) working days after the Contest Period, by 2359hrs on 17 December 2025. By participating in the Contest, you agree to MCCY contacting you for the purposes of the Contest.
- 10 Each winner must, within two (2) days of being notified by MCCY, provide MCCY with their full name and Singapore mailing address for mailing of the Prize to them. Alternatively, if the winner

prefers not to provide a Singapore mailing address, they may collect the Prize from MCCY at Old Hill Street Police Station, 140 Hill Street, #01-01A, Singapore 179639, at such date and time agreed with MCCY, which shall be no later than 31 December 2025.

- 11 If any winner cannot be contacted by MCCY or does not respond to the DM from MCCY within three (3) days of being notified, the winner shall be deemed to have forfeited all rights to the Prize.
- 12 MCCY may select another eligible participant to replace any winner whom MCCY has, in its sole discretion, determined to be ineligible or disqualified, or who is uncontactable or does not claim the Prize as stated in Clause 10 within the timeline specified. MCCY shall not be liable to the originally selected winner.
- 13 All personal details submitted by winners must be accurate and complete. MCCY may, at any time, verify these details, the validity of entries and the eligibility of the winners. MCCY may disqualify any Contest entry that is not submitted in accordance with these T&Cs and/or which tampers with the entry process.
- 14 You agree that MCCY may collect, use, and disclose your personal data as provided to MCCY for the purposes of administering the Contest and in relation to your participation in the same, including publicly disclosing your Instagram handle or name and your entry to the Contest.

General

- 15 These T&Cs shall be governed by the laws of the Republic of Singapore. You agree that the courts of Singapore shall have exclusive jurisdiction to settle any dispute arising out of or relating to these T&Cs between you and MCCY, and you irrevocably submit to the jurisdiction of such courts.
- 16 No third party shall have any rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these T&Cs.
